

# State and Commonwealth Legislative Base

Legislation covering school operations includes those Acts and regulations listed below.

It is important that a School Council understands the legal basis for the operation of its School. Among the most important pieces of legislation are:

- Australian Education Act 2013 (Cth)
- Australian Education Regulations 2013 (Cth)
- Education and Training Reform Act 2006 (Vic.)
- Education and Training Reform Regulations 2017 (Vic.)

### **Primary Legislation**

#### **Australian Legislation**

- 1. Australian Education Act 2013 (Cth)
  - Regulates how the Australian Government provides funding to non-government schools in each State.

#### Victorian Legislation

- 1. Education and Training Reform Act 2006 (Vic)
  - Requires non-government schools to apply to the Victorian Registration and Qualifications Authority (VRQA) for registration
  - Requires teachers at all schools to be registered by the Victorian Institute of Teaching.
- 2. Education Institutions Guarantee Act 1976 (Vic)
  - Permits the Treasurer of Victoria to execute a guarantee in favour of any person or body guaranteeing the repayment of a loan made or to be made by that person or body to the school authority of an educational institution.
  - A guarantee by the Treasurer under this Act shall be executed only in respect of a loan for school purposes approved by the Treasurer and on terms and conditions which have been approved by the Treasurer.

3. Education and Training Reform Regulations 2013 (Vic)

The Education Training Reform Regulations 2017 took effect on 25 June 2017.

- The regulations pertain to:
  - changes made to regulations relating to home schooling commence on 1 January 2018
  - education
  - registration of schools
  - registration of education and training organisations.
- The regulations also provide for and relate to the establishment and functions of the VRQA.

## **Ancillary Legislation**

Schools are obliged to comply with myriad other legislation, including Equal Employment Opportunity, Occupational Health and Safety, Income Tax Assessment, and so on.

For planning purposes local government is also important. Most Local Government Authorities now require schools to produce and maintain a Site Master Plan. As the School Councilis responsible for the school's strategic direction, this Master Plan is inextricably linked to the overall Strategic Plan.

An indicative list of ancillary legislation includes, but is not limited to:

- 1. Superannuation Guarantee (Administration) Act 1992 (Cth), Superannuation Guarantee Charge Act 1992 (Cth), Superannuation Industry (Supervision) Act 1993 (Cth)
  - These Acts regulate the payment of superannuation entitlements by employers to employees and the taxing of those entitlements.
- 2. Income Tax Assessment Act 1936 (Cth) and Income Tax Assessment Act 1997 (Cth)
  - Regulates how the Australian Government taxes income and the responsibilities of employers in this regard particularly relating to employee group tax.
- 3. Fringe Benefits Tax Assessment Act 1986 (Cth)
  - Regulates the taxing of fringe benefits provided by employers.
- 4. Competition and Consumer Act (Cth)
  - Regulates the law in relation to the promotion of competition and fair trading for the protection of consumers.

- 5. Corporations Act 2001 (Cth)
  - Especially as it relates to:
    - insolvent trading
    - the treatment of employee benefits
    - directors' duties.
- 6. Fair Trading Act 1999 (Vic)
  - Regulates fair trading practices including providing for safety of goods or services supplied and to protect consumers.
- 7. Environmental Protection Act 1970 (Vic)
  - Regulates the protection of the environment in Victoria generally.
- 8. Equal Opportunity Act 2010 (Vic)
  - Regulates the law in relation to equal opportunity and discrimination in the workplace, education and other areas.
- 9. Occupational Health and Safety Act 2004 (Vic)
  - Regulates the workplace environment in relation to the health, safety and welfare of persons at work.
- 10. Long Service Leave Act 1992 (Vic)
  - Regulates the payment of long service leave entitlements by employers to employees and the taxing of those entitlements.
- 11. Emergency Management Act 2013 (Vic)
- 12. Fair Work Act 2009 (Cth)
